 provincially regulated financial institution. Aid in the design, implementation and maintenance of
 processes and systems which help manage these risks

- Participating in the management and optimization of contract management systems, serving as the primary contact and subject matter expert to resolve conflicts, mitigate risk, and support business lines in renewals and new engagements
- Ensuring the operational success of procurement platforms such as Gatekeeper, ensuring accurate data registries, workflow efficiency, and comprehensive training for internal leaders and external suppliers
